#### **Project Background**

The National Center for Environmental Compliance (NCEC) was established in 2020 in line with KSA's Vision 2030 and National Environment Strategy (NES) to lead the charge in addressing environmental concerns. A key mandate for NCEC is to monitor the compliance of entities with potential environmental impact by performing inspections on such entities.

The National Center for Environmental Compliance (NCEC) is putting forward the Project to enhance the environmental inspection process and outcomes, in collaboration with the private sector through a Public-Private Partnership (PPP). Under this arrangement, the private sector will be entrusted with a service PPP contract, serving as a valuable partner in achieving environmental compliance goals.

NCEC is the Procurer of the project and assumes the role of both the sponsor and the grantor responsible for any future contractual agreement with the private sector regarding this project.

The Procurer, with the support of NCP, is pleased to invite EOIs in relation to the Operation and Management (O&M) of Environmental Inspection Services in the Kingdom of Saudi under Public-Private Partnership (PPP) Arabia (the "**Project**").

The Project is being tendered as a PPP through a public competition in accordance with the Private Sector Participation Law, Governing Rules and Implementing Regulations.

The Project will be executed by Private Operator pursuant to a Project Agreement to be executed between the Procurer and the successful bidder OR consortium.

#### **Project Objectives**

The objectives of the Project are to transform the Kingdom's environmental compliance framework by leveraging private sector expertise, advanced technologies, and global best practices. This initiative is designed to address current challenges in the inspection system and deliver measurable improvements in efficiency, quality, and coverage. The key objectives of the project are:

- Improve efficiency and effectiveness of environmental inspections: Enhance the efficiency of the inspection
  process by increasing the number of relevant inspections conducted within a specific timeframe. Also
  improve the analysis of data collected from these inspections to extract valuable insights for pertinent
  policy decision-making.
- Improve quality: Ensure the employment of specialized and skilled inspectors who possess the necessary expertise to conduct relevant inspections. In addition, it is crucial to equip inspectors with relevant equipment to conduct efficient and conclusive inspections.
- Improve coverage: NCEC plans to inspect all entities and activities with potential environmental impact.
  However, due to limitations in resources—financial and human—this goal has been challenging to achieve.
  The retained inspection model that incorporates risk-based inspections along with self-monitoring, will help expand the reach to all entities while focusing inspections on most risky or priority sectors and entities.
  This prospective model will reduce the burden on NCEC while optimizing coverage.
- Support NCEC effort on the digitalization of the environment inspection: by providing, if required, a platform
  that allows the efficient implementation of the retained inspection model and data analysis of the selfreports as well as compliance history of entities. The platform is expected to identify priority/ target entities
  for inspections.

The Procurer is seeking a private sector operator to Operate the inspection services for a period of 10 years and carry out the following activities:

- Conduct inspections on facilities with environmental impact, which could reach about 250,000 facilities
  across the Kingdom, supporting registering facilities in the center's database, ensuring the facilities'
  compliance with Environmental Law and relevant executive regulations.
- Hire and training environmental inspectors according to the required skills.
- Provide vehicles and all necessary equipment to carry out environmental inspections according to the best global practices and aligned with the latest technology.
- Provide a modern electronic system to record the outputs of inspection visits and transfer data to the information center of the National Center for Environmental Compliance.
- · Submit comprehensive and quality inspection reports to the center for each inspection visit; and
- Transfer the human resources and equipment to the Procurer or its nominee at the end of the contract duration.

#### **Project Schedule**

The tender process includes this EOI phase and will be followed by an RFQ process to pre-qualify several experienced parties and / or consortia capable of delivering the Project and who will in turn receive an RFP.
